School Estate Consultation Briefing Paper















Introduction

We know our Council's school estate (our school buildings and how we use them) will have to change over the coming years to respond to changes in our communities. Our Council continues to invest more per child in some of our schools compared to the national average. We know that our school rolls are falling across Dumfries and Galloway, many school buildings may no longer be able to provide for the full range of Experiences and Outcomes within Curriculum for Excellence, and we have many more classrooms than we need in many places.

Our ambition is to make the school estate across the authority more sustainable. We need to ensure our schools are the right size and fit for the communities they serve; that are energy efficient; offer equity in education; and are fit for 21st Century learners. An evaluation of the existing school estate, in combination with an extensive consultation with stakeholders, will help us to aspire to these goals and afford all pupils access to the opportunities that Curriculum for Excellence provides. This will help shape what the future school estate may look like and how we prioritise investment to deliver efficient and sustainable school buildings.

Consultation

In order to identify whether changing our strategy will have the desired impact, we will begin by seeking to create a consensus through consultation on the most important factors that need to be considered in delivering a fit for purpose school estate. As a key stakeholder in this consultation, your views and opinions are critically important to help identify and prioritise the fundamental principles for our schools. The feedback and data gathered will define the criteria for our school estate moving forward, to ensure best value and sustainable settings, resulting in an improved learning climate for all our children and young people. Education, in the modern world, looks very different now than it did over 100 years ago when some of our school buildings were first created, and we need to ensure our school estate reflects this, as well as being flexible enough to adapt for the future.

The purpose of this Briefing Paper is to provide key information to enable participants to share, comment and add their views in an informed way when providing feedback during the consultation process.



National Population Decline¹

- The population of Scotland is projected to peak in 2028 at 5.48 million. It is then projected to fall by 1.8% to **5.39** million by **2045**.
- 2045.

 Scotland is the only UK country where the population is projected to fall during the next 25 years.
- The number of people aged 65 and over is projected to **grow by 29.7%** by mid-2045.
- The number of people aged 0-15 is projected to **fall by 22.1%** by mid-2045.

- Dumfries and Galloway has the 5th largest projected **decrease** in population by council area at -2.8% by mid-2028.
- Dumfries and Galloway also has one of the largest decreases in the projected number of children aged 0 to 15 at
 -14.2% by 2028.

- We currently have 98 Primary Schools and 16 Secondary Schools.
- 62% of our schools are classified as Rural or Remote Rural.
- 33% of our school buildings are used by their community.
- 66% of our Primary Schools have a shared Headteacher/in a partnership arrangement.
- 73% of pupils attend their catchment school.
