

- 5 people felt the vision statement was too long.
- 33 comments referred to Themes, Principles or Council operations.

- 15 Welcomed the vision but noted the challenge in achieving it
- 8 commented that this is not currently the situation in the region
- 2 highlighted the need to provide some form of measurements to understand if we achieve the vision




- 25 responses related to increased reference to climate and the environment.


- 30 respondents recognised the importance of growing the local economy



The most popular issue raised was the state of the roads across the region and recommending improvements, which are captured within the first strategic outcome.

- 13 comments referred to the outcome and challenge associated with "Sustainable travel in the region contributes to net zero", outlining a need for greater clarity and understanding.
- 9 comments related to measures and targets for roads improvements.
- 11 comments received related to greater transport links to connect communities and individuals, as well as requesting a reduction in their cost to encourage usage. There were 11 mentions of flood prevention and the challenge that currently exists in the region. These related to comments on dealing with the flooding issue.


- 9 References to the importance of Active and Sustainable Travel within this Theme



- 9 people commented on GIRFEC within this response which ranged from not being a local outcome but relating to Scottish Government legislation, not being achieved or achievable, not understanding what it means as an outcome. Further comments on GIRFEC were identified in the general comments at the end of this appendix. (See separate document re comments on GIRFEC)
- 12 comments referred supporting individuals to achieve personal goals and the need to recognise that not all education takes place in an education facility.
- 4 comments recommended service improvements within Additional Support Needs
- 13 comments on the quality of curriculum and resources available to deliver education across the region.
- 2 comments on providing support to educate parents and family support to be included within the Theme.


- 7 people referenced GIRFEC in the additional comments.

There was agreement with this Theme, however the few comments received highlighted that the Council is not wholly responsible for the health of the population, and referenced the NHS primary role and questioned how much influence the Council could have on major elements of health and wellbeing.

- 9 comments referred to understanding the metrics and actions involved in achieving the outcomes
- 7 people mentioned here is no mention of Mental Health explicitly within the plan
- NHS and the access to health services across the region were raised as an issue by 6 respondents. It was also highlighted by some respondents that this is not in the gift of the Council.

- 7 respondents commented on the importance of good mental health which needs to be supported by the plan
- 13 mentions within the closing section along with 15 comments in other sections relating to the importance of housing to individuals' health and wellbeing
- There were 18 comments relating to the provision of services through NHS, GPs, and Dentists
- 5 comments related to National Care and Social Care improvements/ reform. There was one reference to the need for a new Care home

Staff Focus Groups

There were three focus groups that were held at the start of January 2023 with representatives from all Services attending to provide feedback and thoughts on the draft Council Plan 2023-2028

• Welcomed the principles linking to our behaviours (SUPPORT) easy to remember and reassuring that Elected Members created the new principals in line with the core behaviours which staff created through the 21/22 focus groups

Vision

- Commented that the vision does not reflect the perception of the region now for some client groups. Important to make it clear that the vision is where the Council wants the region to be in 2028.
- Vision was noted as being ambitious and staff would like to see a vision achieved but recognised that this will be a challenge.
- Welcomed the inclusion of visitors and invest in the vision within the vision statement.
- Staff stated the vision statement could be shorter, but noted and welcomed the final sentence as it added continuity and would be easier to remember.

Themes

- The themes were welcomed and there was broad agreement that these were the areas for the Council to focus on.
- Welcomed the concept that the themes were not based upon directorates or services and would reduce silo working.
- Understood that actions and activities could and would operate across themes and outcomes.
- There could be clearer reference to the role housing, as some client groups require this support.
- Active travel and culture were areas some staff requested more references within the document.

Format and Reporting

- The layout of the document was welcomed and made it easy to understand and follow.
- One page Council Plan is helpful and easy to reference.
- Currently no reference to the previous Council Plan, could there be a paragraph to celebrate success.
- Staff were keen to ensure that the Council Plan is monitored and reported regularly.

- Ensure access and equality when publishing and reporting the final Council Plan.
- Staff requested that the document remains live and that good news stories are aligned and reported regularly.

Managing the disposal of trade waste onto the sites – those making a booking are agreeing to not bringing in trade waste which would not comply with our licences for the sites. Trade waste, including those undertaking a "service" to take waste to one of our sites should be paying to deposit waste. Understanding the site usage – to date there have been over 600,000 bookings across the 12 sites in D&G with very few complaints in comparison to the amount of use these sites have had.

Managing the sites in terms of ensuing short breaks for sites with single person operation (allowing general tidying to be undertaken) plus simplifying the process for emptying skips without impacting upon the public use of the site i.e. by scheduling times at which bookings are unavailable. Having customer details allow us to contact them in the unfortunate event a site is closed, due to an emergency for example, redirecting them to a possible alternative site, thus relieving the customer of any unnecessary journey or inconvenience.

By asking about your transport (trailer) we can offer double slots for those who may need more time to deposit their waste.

By asking about specific wastes we can direct you to the sites with availability for this type of waste e.g. Asbestos, which is only accepted at certain sites.

We will continue to monitor and review the booking system to allow us to adapt appropriately to possible changes in the future
