We anticipate funding applications will come from a range of sources which may include individuals, community groups, residential and commercial property owners, empty home owners and Registered Social Landlords.

These examples are not intended to cover all the circumstances where funding may be awarded. Large strategic projects that require a significant level of funding will be presented to the Communities Committee for consideration.

Each application will be assessed based on it's ability to deliver a number of priorities including contribution to town centre regeneration, increasing the supply of affordable housing and bringing empty properties back into use.
