Community Council Discretionary Grant 2021 – 2022 - Reminder

Thank you to all the Community Councils who have already submitted the monitoring form and relevant documentation to receive your 2021 – 2022 Discretionary Grant. As per the letter issued on 7 October 2021, we kindly ask that all <u>forms</u> be submitted by no later than the 31 December 2021.

As you will be aware, **Paragraph 11.6.3 in the Scheme of Establishment** states part of the criteria is "evidence of a minimum of 6 meetings being held throughout the previous financial year", however, on this occasion only, due to the restrictions imposed as a result of the coronavirus pandemic we will accept evidence of having met at least ONCE in the previous financial year. This this will be sufficient on this occasion only.

The criteria outlined in the **Scheme at Paragraph 11.6.3** will apply to all when applying for next years' Annual Discretionary Grant, therefore, to be able to apply for the full amount you will be required to evidence of 6 meetings including an AGM having been held between 1 April 2021 and 31 March 2022.

Urgent – Book Your Booster Call Now Amid Concerns Over Covid Variant

A BID to deliver COVID-19 vaccinations as quickly as possible in the face of the Omicron variant means everyone eligible should book their booster now. As the dangers posed by the new variant continue to be assessed, everyone aged 40 and above, unpaid Carers and those who are household contacts of people who are immune-suppressed are being urged to schedule their vaccination by visiting https://vacs.nhs.scot/csp or phoning 0800 030 8013. The gap for everyone in the above categories between second dose and boosters has been reduced from 24 weeks to 12 weeks, so everyone in these groups who is 12 weeks from their second dose should now book their slot – irrespective of what is stated on the portal. As the situation emerges regarding the new Delta and Omicron variants, it is as important as ever to ensure that we all continuing to strengthen our compliance with existing protocols. Whilst we recognise that there are currently no restrictions in place that prevent face to face meetings happening, the reality is that under the current circumstances we would strongly advise that consideration should be given to meeting virtually wherever possible. However, where this is not possible and if your meeting is essential then you must adhere to all the current Government Guidelines which includes the following mitigations:

- Test for Covid regularly.
- Lateral Flow Testing is an important route and is available widely
- On any occasion that you intend to socialise or mix with people from other households - whether that is in a community hall, restaurant, house or shopping centre – please do a Lateral Flow Test first.
- Wear face coverings on public transport, in shops, and when moving about in hospitality settings.
- Keep windows open to improve ventilation.
- Follow all advice on hygiene.
- Work from home if you can.

Planning and Licensing – Transforming Planning News Update

The planning system in Scotland is in the process of being reformed with significant emphasis being placed on community engagement in the planning process, place making, community health and wellbeing, climate change and sustainability. One of the first stages in the reform programme is the publication of National Planning Framework 4 (NPF4) which the Scottish Government published on 10 November 2021. The Framework is a long term plan for Scotland looking to 2045 that will guide spatial development, set out national planning policies, designate national developments and highlight regional spatial priorities. Once approved and adopted by the Scottish Parliament, the Framework will be part of the development plan which means it will influence planning decisions and the content of the next Local Development Plan for Dumfries and Galloway. The Scottish Government are inviting everyone to have their say on the document and have created a web page with further information on the Framework along with how you can get involved - Get involved | Transforming **Planning.** A Community Grant Scheme is available to support communities to engage locally, this would assist Community Councils in carrying out their role in gathering and representing the views of their community further information on this and is available here. Dumfries and Galloway Council will be submitting its own response to the consultation and would urge communities and individuals with an interest to get involved in the consultation events and submit their comments by the deadline of 31 March 2022.

Licensing News

Legislation on short term lets is now before Parliament and under this legislation, Councils will be given powers to ensure short-term lets are safe and meet the needs of their local communities. All local authorities will be required to establish a short-term lets licensing scheme by October 2022. The legislation was developed after residents across Scotland raised significant concerns about the impact of short-term lets on their communities, including noise, antisocial behaviour and the impact on the supply on housing in some areas. It will ensure the needs and concerns of communities are balanced with wider economic and tourism interests.

Response to Pandemic

New Report Published on Community Empowerment

The Accounts Commission and the Auditor General for Scotland have published a report on Principles for community empowerment, detailing how Scotland's public bodies worked with communities and empowered community organisations to respond to the Covid-19 pandemic. The report features case studies and examples of best practice from across Scotland which illustrate the value and importance of the community response to the crisis, especially in support of the most vulnerable in our society. The community response to Covid-19 demonstrated how community organisations, including Community Councils, can be more effective when bureaucratic hurdles are removed. Report authors state that communities should be supported to take more control over local decisions and assets, using routes through Community Councils and local authorities to enable local people to participate in decisions about local issues. We are continuing to see a number of enquiries being logged through the CCES, Community Council Enquiry Service relating to road defects. We would like to ask all Community Councils to note that the preferred route for reporting road defects continues to be the REPORT IT system.

The REPORT IT system allows the defect to be plotted on a map to ensure that the correct location is identified and the person logging the defect is kept informed of its status and outcome. All defects are also logged on the Council's REPORT IT system in order for them to be processed for inspection and prioritised for repair. Each defect is assessed in accordance with current Dumfries and Galloway policy and the Well Managed Highways Infrastructure Code of Practice which allows us to determine the level of risk posed by the defect and to prioritise and schedule for repair. We thank you for your support and assistance in this matter.

Royal British Legion Scotland

Royal British Legion War Memorial Project

A total of 14 entries across 4 categories were received, judged by councillors and a Legion Scotland representative. Dumfries and Galloway's Armed Forces Champion, Cllr Archie Dryburgh, commented that 'the brave men and women whose names are listed on these memorials are long gone but in many cases their descendants are still in that town or village. Even where there are no relatives anymore it was clear from our visits that there is enormous respect for their memory in the way the memorials are looked after'. Winners are as follows:

Large Community with Garden joint winners Lochmaben and Dalbeattie

Small Community with Garden Closeburn with Kirkconnel runner up

Large Community without Garden Parish of Penningham (Newton Stewart)

Small Community without Garden Whithorn with Bargrennan runner up The communities of Lochmaben and Auchencairn provide a summary of the community projects they have been involved in below.

Lochmaben War Memorial Project - Colin Davidson, Chairperson of Lochmaben and District Community Council commented that 'Lochmaben Community Council readily acknowledge and appreciate the help, support and assistance of local businesses, residents, children and DGC in helping to deliver this project in time to mark the centenary of the Royal British Legion'. Carol Rogerson, Community Councillor, provides an update on the actions carried out. 'The youngest helper was 4 years old (her dad is a veteran who also helped). Three boys who have a great, great uncle named on the memorial washed and polished the granite. The local nursery have made poppies which they place in the flower beds in time for the Remembrance service. The painting of the flower containers was carried out by a group of 4, Carol, Liz, Angela and Carol, they also tidied the flower beds. A local roofer offered to do the scaffolding, this enabled the figure to be cleaned and when a fine crack was discovered on the statue a local builder quickly offered his help. The ornate ironwork and gate have been carefully restored and the funds enabled us to purchase the specialist materials required. A local company donated the granite chips which were needed to patch in the space surrounding the memorial. Our next task was to create the stone poppies, they have become a real talking point in Lochmaben. From a personal point of view, the work has been rewarding and I feel proud of our community coming together to make sure our War Memorial looks its best, as it should, but especially on this 100 year Anniversary'.

Auchencairn Primary School War Memorial

Project - an account of recent activities was provided by Auchencairn Community Council, Treasurer George Makins

As Remembrance Day approached this year, staff at Auchencairn Primary School decided to bring some of the older children to the village War Memorial to help understand why this memorial was built and what its significance is in the community. They also contacted a member of Auchencairn History Society, who thought this was an excellent project and was happy to be involved with it. On the Tuesday following Remembrance Sunday, a group of Primary 4–7 children with two members of staff walked from school to the War Memorial. The task was to draw the War Memorial, but first there was a short discussion with the member of the History Society who was present which the children found very interesting.
