

**ASSET TRANSFER UNDER THE COMMUNITY EMPOWERMENT ACT**  
**DUMFRIES AND GALLOWAY COUNCIL DECISION NOTICE - APPROVAL**

**23 November 2022**

This Decision Notice relates to the Community Asset Transfer Request made by Lockerbie Squash & Racketball Club (SCIO), in relation to the asset transfer of Common Good Land, Glasgow Road, Lockerbie, DG11 2AR.

The Council's Finance, Procurement and Transformation Committee considered the request at its meeting on 8 November 2022 and agreed the following:

**NOTED**

17.1 the Lockerbie Squash and Racketball Club Asset Transfer Request as laid out in the Stage Two Asset Transfer Application (Appendix 1 to the report), Business Plan/Accounts (Appendix 2 to the report) and Project Plan (Appendix 3 to the report);

17.2 the outcome of Officer Assessment of the Request in relation to the Councils requirement to meet best value, as detailed at paragraph 3.5 to the report and the Officer recommendation at paragraph 3.10 to the report;

17.3 the outcome of the Social Value assessment of the proposed transfer as detailed at paragraph 3.6 to the report;

17.4 the recommendation from Lockerbie and Lochmaben Common Good Sub-Committee of 20 September 2022 at paragraph 3.11 to the report;

17.5 **AGREED** to a Community Asset Transfer of Lockerbie Squash and Racketball Club, Glasgow Road, Lockerbie, DG11 2AR for the land on which the Club sits and the adjoining land, all of which extends to approximately 11,500 square metres, to Lockerbie Squash and Racketball Club, for the sum of £1 sterling

You or your legal representative need to write to the Council's Legal Team making your formal offer for the property for the agreed amount. This offer must be made no later than 23 May, 2023 but can be made earlier if your group is in a position to do so.
