Where an organised function or Golf Club event is being held then children (accompanied by a responsible adult) and young persons (accompanied by a responsible adult) will be allowed access until the terminal hour.</p> <p><b>AGES</b> – All ages</p> <p><b>TIMES</b> – Children and young persons are allowed in the premises up to 19.00hrs where such entry is ancillary to playing golf, or for catering purposes or the purchase of non-alcoholic drinks.
